#### ROLL CALL

Chair Page called the meeting to order at 3:02 p.m. at the Mammoth Lakes Tourism and Recreation Conference Room, 2520 Main St, Mammoth Lakes, CA 93546. Present: Finley Torrance, Dan Holler, Alan Jacoby, and David Page.

#### PUBLIC COMMENT

#### ADMINISTRATIVE ITEMS

- 1. Approval of the Agenda: approved.
  - a. Move Agenda item #5 to the end.
- 2. Introduction of Finley Torrance:
  - a. Rich Boccia gave a background on the reason for having a new member of the committee; Finley is replacing Mark Brownlie.
  - b. There was a discussion about if it will be possible to have "subs" for some of our Committee members. (Lesley will look into the Brown Act )
- 3. Approval of minutes from May 12, 2016: Motion to approve the minutes (M Page, 3-0)
  - a. Bring back March 24, 2016, minutes for approval
- 4. Trails Coordinator update:
  - a. Signage update given, Lake George signs will be put in "as soon as we get them," (possibly 8 weeks); College Connector path will be going in this season; a little less than 90 new signs will be put in around Mammoth Lakes in total. MMSA is looking to match their signs with the rest of the trail system.
  - b. Trail Maintenance program update given: Mammoth Rock trail completed, currently working on Mammoth view trail. Data collection is occurring on trails where maintenance is or will occur, to update the trail maps. Horseshoe biking trail is one that is recommended as a beginner trail, but has some roots and other hazards that need to be fixed in order to be a true beginner/intermediate trail; that is happening later this season; there are areas where the trail should be realigned, but the current agreement with the Forest Service does not allow that at this time,
- 5. SHARP Environmental Update:
  - a. Draft letter from Dan Holler outlining the next steps and "Tasks" that need to be done.
  - b. FYI—Borrow Pit is now being called "Sherwins Access" Trailhead. Summer and winter trailhead. Town and FS have spoken about the parking design, etc.
  - c. Task One connects trails from Mammoth Rock Trail to the Sherwins Access, the goal is to begin work on these trails next summer.
- 6. SEMBA Fat Bike Winter Trails Proposal:
  - a. Alan Jacoby as president of SEMBA spoke about how they are proposing an modernized amendment to the Inyo National Forest order #04-92-11 which is 24

years old, to allow fat bikes on groomed trails. Other Forests have begun to adopt these types of amendments, which this one is based on.

- b. What trails are being considered for use? SEMBA is not making the decision on the specific trails, and hopes that this will lead to a dialogue, and it is up to the FS to decide what trails are the most suitable.
  - i. Not tied with a NEPA process, under the discretion of the Forest Service supervisor.
  - ii. The Committee discussed if this is appropriate for the MTC. Definitely should go to MLR. MTC supports the dialogue, but not the body to specifically write off on this letter.
  - Motion to allow MLR Board to have a discussion about this the letter, and approve MLR being the one to sign off on the letter, (M Torrance, S Holler, 3-0, 1 abstain)
  - iv. Public Comment from Friends of the Inyo says that they support the dialogue with Forest Service on fat biking.
- 7. Consider formation of Winter Recreation Task Force:
  - a. David Page gave summary of a desire for a winter recreation master plan—"travel plan."
  - b. Discussion included reminder that Winter Recreation Summit debrief happening next week, and will be discussing some of the issues mentioned. Holler mentioned not allowing this to be a Measure R funded, would not support another WRS-type project. This is different than WRS in terms of regional, there is a need for "buy-in" from groups.
  - c. Public Comment from Wentworth says he would like to see what the FS is going to do with some of the mentioned context, and "back fill" the decisions.
- 8. Lake George connector path:
  - a. Hayes gave an update. Still on schedule to be done end of September.
  - b. Intersection that it ends at has been adjusted, with extra signage for safety.
  - c. Hayes also gave an update on the Main Street pedestrian pathway, which is out to bid, and other pedestrian projects that are happening.
- 9. Approval of Project Initiation Sheets for 2016/17:
  - a. Joel Rathje gave a summary of the PI sheets:
    - i. Inyo Craters Shady Rest Planning: Holler brought up the point that the Forest Service needs to be involved with the planning on the front end, and not brought in later. To be added into the PI sheet: FS, MLR, TOML, "collaborative planning efforts,"
    - ii. New PI sheets were given an overview.
    - iii. Change Signage and Wayfinding-Map Updates & Repair (#052\_03) to \$20k instead of \$10k




## Mammoth Lakes Nordic Trail System 2015-2016 End of Season Report
